



## **Airfield Facility Requirements**

Airfield Requirement	Adequacy (20 years)	Notes
Airfield Capacity	Adequate	Remains <50% throughout planning period
Number of Runways / Wind Coverage	Two; 99%	Both Runways needed for wind coverage
Runway Length, Strength & Width	Adequate	8,500' is adequate (Existing & Future)
Taxiway Width	Adequate	75' satisfies requirements
Full Parallel Taxiways	Deficit	Consider Runway 1-19 eastside taxiway
Airfield Lighting	Adequate	High Intensity, Touchdown Zone, Centerline
Approach Lighting	Adequate	MALSR (with Special Auth.) or ALSF-II
Navigation Aids	Adequate	ILS, RNAV, VOR, PAPI, REILS
Hot Spots (Potential Risk Location)	None	ALB has no identified FAA hotspots
Airspace Obstructions	Trees / Hills	Regular maintenance required

Security Screening Area (with current project)	4,103 SF	11,100 SF	12,044 SF
Outbound Baggage Conveyance/Screening	Separate	In-line	In- Line
Gates (with reconfiguration/common use)	14	16	16
Concessions	25,900 SF	25,900 SF	37,911 SF
Baggage Claim Devices	3	3	4
Vehicle Parking Spaces	7,031	8,628	9,874

#### **Support Facility Requirements**

Support Facility	Notes
Fixed Base Operator (FBO)	Hangar storage deficiency (60,000 SF)
Maintenance, Repair, and Overhaul (MRO)	Cannot accommodate future fleet mix dimensions
Aircraft Rescue & Firefighting (ARFF)	Outdated facilities & Undersized
Snow Removal Equipment (SRE)	SREs currently stored outside
Fuel Farm Capacity	Expand Storage Capacity 25% – 35%
Air Traffic Control Tower (ATCT)	Cab height requires routine tree clearing




#### **Environmental Overview**



#### **Resources/Ecology**

- Terminal Building Development Considerations:
  - Historic Resources: The terminal is within the Watervliet
     Shaker Historic District, coordination is required
- Airfield Development Considerations:
  - Shaker Creek: The 100-year floodplain avoid or mitigate impacts
  - Wetlands: New developments will likely have impacts & require permits
  - Stormwater: New impervious areas may require substantial storm drainage improvements
